



HUMBER STUDENTS' FEDERATION FINANCIAL NEED BURSARY

The Humber Students' Federation (HSF) has designated a portion of its budget to assist students who have a proven financial need. This bursary will assist students who are experiencing hardship due to their financial situation. Preference will be given to students who are not on OSAP and have demonstrated a commitment to their program of study.

The amount of the bursary may vary. It is only a supplement and is meant to relieve a student's immediate and temporary need.

ELIGIBILITY CRITERIA

TO QUALIFY FOR A FINANCIAL NEEDS BURSARY, APPLICANTS MUST:

- Be a full-time student and paying full-time fees
- Be a Canadian citizen, permanent resident, a protected person or a Study Visa student
- Have proven financial need
- Have not received a student financial aid bursary this academic year

THE PROCESS:

- Bursaries are available throughout the academic year, but students must demonstrate progress in their program in order to be considered
- Submit a completed application to the HSF office at your respective campus

WHAT IS REQUIRED?

- Complete the Application Form on the next page
- Attach a **detailed** letter outlining your current financial situation and stating how this bursary will assist you in meeting your educational goals
- Proof of expenses (where possible, please provide copies of your expense bills)

T4A:

All bursary recipients will receive a T4A for income tax purposes. All Humber and Guelph-Humber awards, bursaries, and scholarships as well as other sources of financial assistance, are subject to income tax.
